3. Upon approval of your booking and receipt of an invoice by Classical:NEXT GmbH, you are liable to pay the applicable amount for your advertisement.
4. Payments are to be made in € (Euro) currency only. Prices exclude VAT, which will be applied in accordance with EU regulations, with a rate of 19% in Germany.
5. Payments can be made by credit card (Master/VISA) or bank transfer.
6. The invoiced party will cover any additional bank charges.
7. Booking deadlines indicated in the booking form are also payment deadlines. If payment is not received by the stated deadline, the higher rate will be charged.
8. A booking is only considered valid once the advertisement information is approved and full payment is received.
9. All cancellation requests must be submitted in writing. Refunds will be subject to a 20% administrative charge until Friday, 25 April, 2025. Refunds will not be issued after Friday, 25 April, 2025.
10. No refunds for Bag inserts will be issued after Friday, 25 April, 2025.
11. Classical:NEXT GmbH will not be liable for any third-party claims resulting from changes to the event's format, date, or location.
12. The place of jurisdiction for disputes concerning the present agreement is Berlin, Germany. The agreement shall be governed and construed according to the laws of the Federal Republic of Germany.

## VAT Information

All prices exclude VAT and credit card fees. VAT will be applied in accordance with EU regulations, with a rate of 19% in Germany.

Under the German VAT Act (UStG § 3a, Paragraph 3, in conjunction with Paragraph 4, No. 2): Customers outside the EU who purchase Classical:NEXT advertisements are not required to pay German VAT. Customers within the EU must either provide a valid VAT ID number or pay 19% VAT. Customers in Germany are required to pay 19% VAT.
